Public Hearing Notice of Discontinuance of Maintenance on a Portion of Munsell Street, Belchertown, MA

The Belchertown Board of Selectmen will conduct a public hearing on **Monday, December 11, 2017, beginning at 7:45 p.m.** in the Selectmen's Meeting Room on the first floor of Lawrence Memorial Hall, 2 Jabish Street, Belchertown, MA for the purpose of considering the discontinuance of maintenance of a portion of the way known as Munsell Street, starting at the point shown as "End Roadway Pavement 2" Overlay", or as Station 11+00, on a plan entitled "Roadway Improvements Plan & Profile," prepared by Sherman & Frydryk, LLC, dated 6/20/14 (which point is also approximately 2,615

feet from Gold Street), and terminating at its intersection with Gulf Road, to the extent that such portion of the way is deemed to be a public way, has become abandoned and unused for ordinary travel and that the common convenience and

necessity no longer require (to the extent it ever did) said way to be maintained in a condition reasonably safe and convenient for travel; and (2) declare that the Town shall no longer be bound to keep such portion of Munsell Street in repair, to the extent

it ever was so bound.
