Bonsignore takes second in Buzz Chew 200

RIVERHEAD, N.Y. – Justin Bonsignore captured a second-place finish in the Buzz Chew 200 at Riverhead Raceway on Saturday night. The three-time NASCAR Whelen Modified Tour champion was out front of the seventh race of the season in the final stages, but Riverhead weekly regular Kyle Soper found his way around, capturing his first Whelen Modified Tour win.

Bonsignore qualified sixth and quickly worked his way to the front, challenging inside the top-five for the entire race. Bonsignore passed Soper originally for the lead on lap 143 and was at the front of the field until lap 189, when Soper slid around. The No. 51 Phoenix Communications Inc. machine would cross the line second after 200 laps – a strong run – and the second podium in a row for the Ken Massa Motorsports team following a win at Monadnock Speedway last weekend.

“It was an amazing race,” Bonsignore said. “Our car was really good through the middle section of the race, and once we got the lead, I thought we were in good shape. I just started to free up a little bit at the end. Kyle’s car was just way too good. All in all, a good run for us. A win last week, and a

second-place today.”

Bonsignore will return to the track on Saturday, July 9, at Wall Stadium Speedway in New Jersey for the NASCAR Whelen Modified Tour main event.

Six-time NASCAR Whelen Modified Tour champion Doug Coby captured a 10th place finish in the race. Competing for Tommy Baldwin Racing in the Buzz Chew 200, Coby qualified 10th, and ran inside the top-10 for the duration of the race, finishing right where he started.

The run for Coby and Baldwin together marked their fourth top-10 finish in four races this year. Through seven NASCAR Whelen Modified Tour races, Tommy Baldwin Racing leads by 22 points in the owners championship standings, as the series hits the halfway point of the season in their next event. The top-10 finish at Riverhead came in the second of three races at the New York bullring in 2022.

Mayhew Tools joined the famed No. 7-NY for this special event.

“We just missed things a little bit in qualifying which caused us to start 10th,” Coby said. “And we had a good enough car to come up from 10th to third, but I

got pinned on the bottom on a restart and maybe used up a little bit of what I had. We certainly didn’t have the car with the same forward drive we had in May, and that’s just a product of a couple of small adjustments that we maybe needed to make, and the track being a little bit different with how they prep the surface.”

Coby will return to the track at Seekonk Speedway with the Monaco Modified Tri-Track Series on Wednesday, June 29.
