Monson resident Laura Gouvin also left the Mutiny a little bit early to begin an internship with a baseball team in the prestigious Cape Cod League.

Two of the Mutiny reserve players for the playoff match were Lily Fabian (Monson), who played the entire second half, and back-up goalie Julia Robak (Chicopee).

Another local player listed on the Mutiny roster is Alexis Legowski, who lives in South Hadley. She missed most of the regular season because of an internship in Boston. Legowski is entering her senior

year at Northeastern University. She gave the Mutiny faithful supporters something to cheer about late in the second half.

FC Buffalo, who made the long trek from Western New York on gameday, took a 1-0 in the 39th minute following a goal by Carissima Cutrona.

A couple of minutes later, Mutiny starting goalie Bella Mendoza, who attends UMass-Amherst, made an outstanding diving save on a breakaway opportunity by Ella Rudney keeping the score 1-0.

The visiting squad managed to hold onto the lead until the 82nd minute.

That's when the Mutiny managed to tie the score at 1-1 following a free kick.

The kick was taken by Anna Carson from outside of the box on the right side and Legowski headed it into the left corner of the net.

"I was feeling great after we scored the tying goal on the free kick," Linnehan said. "We felt like that we had the momentum and we decided not to change anything. Then unfortunately they scored the winning goal."

The Mutiny had a couple of scoring chances before Djeynaba Thiam, who entered the match for Buffalo during the 77th minute, scored what turned out to be the game winning goal in stoppage time.

Even though the Mutiny season has come to an end, they'll be plenty of exciting action at Lusitano Stadium this weekend.

of veggies fizzing away. The beets will give me another harvest, but I'm sure we will be wanting more come September and early October so I will likely sow another batch as spaces begin to appear.

One big vacant area will be where the peas were. I got three really good pickings before they petered out. The peas were picked, shucked, blanched, chilled and then pre-frozen on a cookie sheet before being placed in reused quart size yogurt containers. I usually leave a few pods on the plants to yellow and dry. The seeds therein will be used for next years crop. The only problem is that voles or

chipmunks have been devouring the dried peas right out of the pods still hanging on the plants. Hopefully there will be enough left for me.

There is nothing like young zucchini. They are so much more tasty when only six or seven inches long and a couple inches in diameter. We've made bread, roasted them, cut them into spears for eating with dip and even attempted to ferment. All yummy. I will be removing the first sowing soon; it's gotten way too big (a sprawling three and a half feet). Another sowing is possible - get your seeds in now for a treat in late September early October.

Speaking of sowing, I did end up har-

vesting my garlic last week and in its place sowed a double row of carrots. I have never had much luck with this particular crop, but I thought it was worth a try. I'll be watering the seedbed a couple times a day in this heat; it's imperative that carrot seeds stay moist until germination.

Although my broccoli plants are riddled with holes from every type of cabbage worm, the 11 heads I picked yielded only one worm upon processing. I am so glad I didn't yank them up. I wanted to - they were a bit of a downer every time I visited the garden, but with some to eat and two and a half large freezer bags filled I'm vindicated a bit. Freezing went well. I was careful to put the colan-

der of spears into the pot of boiling water and time three minutes only before plunging into ice water. Pre-freezing on a cookie sheet here too will make for easy meals, taking only what I need for a recipe from the bag.

Well, you can see that I am trying to think of the harvest as reward, not a boatload of work. Keep it coming.
