The second half of the Agawam Cultural Council's Applause Series Season 19 begins with a virtual performance of Sheryl Faye's "I Dissent" — her one-woman show based on the life of Supreme Court Justice Ruth Bader Ginsburg. The performance will be broadcast on Agawam Comcast Channel 15 and streamed on www.agawammedia.tv at 7 p.m., Friday, Jan. 6.

Ruth Bader Ginsburg was an American lawyer and

jurist who served as an associate justice of the Supreme Court of the United States from 1993 until her death in September 2020. She was the second woman and the first Jewish woman ever appointed to the Court and became the longest serving Jewish Justice. She championed fairness and equality and objected to different expectations for men and women, prejudice against minority groups, and women having fewer job opportunities than men.

Bader Ginsburg served on the national board of the ACLU (American Civil Liberties Union) launched The Women's Rights Project, and was a leading voice for gender equality, women's interests, civil rights and liberties. Her life was one of achievement: as a lawyer, professor of law, a judge, and Supreme Court justice; she stands out because she was unafraid to dissent, disapprove, and disagree with conditions of unfairness and inequality. This show is the inspiring story of how she changed her life—and ours.

Since 2003, Sheryl Faye has masterfully brought to life important historical women in performances across the United States. Her one-woman shows immerse the audience in a multimedia learning experience that captivates viewers and sparks their interest to explore more.

The Department of Public Works is pleased to announce that Republic Services will be providing a collection of Christmas Trees during the week of Jan. 9 to 13. Christmas trees will be collected on the same day as scheduled trash collection. Please be aware that the regular trash truck will not be collecting trees, a separate truck will be running for the collection of trees. Christmas trees 7-feet tall or larger must be cut in half and placed on the tree belt no earlier than 7 a.m. of the collection day listed above. Trees in plastic bags will not be collected. It is not the responsibility of the hauler to dig out trees buried in the snow due to plowing or excessive snowfall prior to the scheduled collection days. In the event of a snow delay during the scheduled collection week, residents should make alternative arrangements to recycle their trees at the Bondi's Island Landfill. Collection routes for trees will not be rescheduled. Residents may dispose of trees prior to or after the scheduled collection days at the Bondi's Island Landfill.

Mary was a wonderful wife, mother, sister, grandmother, and friend within her close circle. She left this world exactly how she lived her life...on her own terms. Mary fiercely loved and stood by her family no matter what, and she never hesitated for a moment to let you know where you stood with her. She worked very hard as a waitress much of her adult life, working at the Homestead Inn, the Family Dining Room, and the Laddibuck Restaurant over the years, all in Ludlow.

Mary loved her home and always

strove to have it look nice both inside and out. She had a flair for decorating and loved shopping for different kinds of things that really made a house a home. After retiring, Mary and Wally spent much of their time watching their grandchildren. They loved reading, taking walks, doing jigsaw puzzles, and playing

cards and board games with them.

Mary loved watching any kind of movie and reading any kind of book or newspaper, often sharing ideas for both with her niece Margaret Ann. She also was a big fan of professional golf and football, watching both on Sunday afternoons. Like her mother, she was an avid crossword puzzle enthusiast, and she treasured her mother's dictionary that she kept to work on them. Mary also loved to cook and eat a fine meal, and she was known to drink a cocktail or two while dining, reading, or watching a movie.

Mary's children would like to extend their heartfelt thanks to the entire staff at Life Care Center in Wilbraham where Mary lived the last 16 months of her life after suffering a serious stroke in July 2021. They loved and accepted her for all that she was...stubborn, sassy, hard-working, and independent.

We personally thank the entire Rehab Team there along with many of the nurses and special aides that worked with her daily to provide her with the help and care she needed to the very end.

Mary's children have decided to have a funeral Mass and burial in the spring. She will be buried with Wally on May 31, 2023, 65 years to the day after they were married.
