State Legislators call on MassHealth to eliminate cliff effect and spend down provisions

BOSTON - Ninety three Massachusetts State Legislators have asked Mass-Health to implement two changes to help seniors and people living with disabilities access home and community-based care.

The letter elevates recent guidance from the federal Centers for Medicare and Medicaid Services which gives states greater flexibility in applying income and resource eligibility standards to make Home and Community Based Services more accessible.

Currently, seniors and people with disabilities must have income under 300% of the federal benefit rate in order to be eligible for a home and community based services waiver. If an applicant receives income even one dollar over that limit, they must spend their income down to \$542 a month to qualify for the program.

The letter called on MassHealth to implement the following changes to eliminate cliff effect and spend down provisions:

1. Disregard income over 300% of the federal benefit rate for HCBS applicants aged 65 and older and those living with disabilities; 2. Disregard the assets (and income) of the spouse of the HCBS applicant.

Both of these changes are permitted under the recent guidance from CMS. These changes would eliminate the spend down requirements, which is a significant barrier to community-based care and would allow more nursing home eligible individuals the choice to stay in their communities and receive care and services in their home.

The other area of guidance provided in the CMS letter addresses the issue of spousal assets. The Affordable Care Act required states to allow spouses to keep a community spouse resource allowance, in an effort to ensure that spouses were not impoverished. Although this was a very positive change for spouses in other states, in Massachusetts it put a limit on the asset amount the spouse could keep where there had been no limit before.

This new guidance allows Mass-Health to return to the policy in place before the Affordable Care Act, ensuring spouses keep their assets. This change also facilitates community-based care as it makes HCBS services accessible to seniors without the concern of impoverishing their spouse.

PURPOSE: The purpose of this hearing is to provide the public with the opportunity to become fully acquainted with the proposed Intersection Improvements at Montgomery Street, Granby Road, and McKinstry Avenue project. All views and comments submitted in response to the hearing will be reviewed and considered to the maximum extent possible.

PROPOSAL: The proposed project consists of (1) reconfiguring the intersection of the ramps to/from I-90 (the Massachusetts Turnpike) with Montgomery Street to construct a modern roundabout, (2) removing the traffic signal and constructing two roundabouts: a peanut-shape roundabout at the intersection of Granby Road and Montgomery Street, and an Oblique Roundabout at Granby Road and McKinstry Avenue, and (3) constructing a raised median along Montgomery Street between the Interstate 90 Entrance and Granby Road to improve safety by removing left-turn access to and from the abutting properties and driveways. Access is proposed to be accommodated by utilizing the roundabouts to reverse direction of travel. (4) Pedestrians and bicyclists will be accommodated through shared-use paths, generally 8 - 10 feet in width and crosswalks with rectangular rapid flashing beacons as needed will be provided across each leg of the roundabouts.

A secure right-of-way is necessary for this project. Acquisitions in fee and permanent or temporary easements may be required. The City and MassDOT are responsible for acquiring all needed rights in private or public lands. MassDOT's and the City's policies concerning land acquisitions will be presented in the hearing.

BOSTON - Data Privacy Week took place this year from Jan. 24-28. Edward A. Palleschi, Undersecretary of the Office of Consumer Affairs & Business Regulation suggests the following tips to aid consumers and businesses on how to protect their devices from threats.

One: always back up your data on a regular basis, as this allows one to retrieve any lost data more easily.

Two: set up strong passwords. Utilize a password manager to keep track of complex passwords. Three: when able, use two-step authentication. This allows for stronger protection against hackers attempting to access someone

Four: install antivirus and malware protection software on personal and professional computers. Five: install ad blockers on the web browsers commonly used on each device. Six: lock your screen. Setting the device to automatically close out of the screen after 15 minutes of inactivity is advised.
