Program on Indian Reservations (FDPIR); or Temporary Assistance for Needy Families (TANF), if the State program meets Federal standards.

An application is not required for free meal benefits for Assistance Program participants, and all the children in the household are eligible for free meal benefits, according to the press statement. "If any children were not listed on the notice of eligibility, or if a household does not receive a notice of eligibility, the household should contact the school to have free meal benefits extended to them," the schools shared.

Participants in the Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) may be eligible for free or reduced-price meals, but they will need to turn in an application including household size and total income. When known to the Belchertown Public Schools, households will also be notified of any child's eligibility for free meals if the individual child is considered "Other Source Categorically Eligible," because the child is categorized, as defined by law as: foster; homeless; migrant; runaway; enrolled in an eligible Head Start, or enrolled in an eligible pre-kindergarten class.

If any children were not listed on the notice of eligibility, the household should contact the school about their eligibility through the list above, school officials said, or should submit an income application. Households notified of their children's eligibility must contact the school if the household chooses to decline the benefits.
