"Tommy has a deep racing history in the Modified community and when you drive for him, you know he's going to bring fast cars to the track," Coby said. "Having the opportunity to work with them again in 2024 to simply try to win races is something I'm really excited for."

Coby and Baldwin first paired together in 2022 and won events at Riverhead Raceway and Lee USA Speedway in their first two races together. They also picked up a victory at Langley Speedway that season - one that saw Tommy Baldwin Racing seal the Whelen Modified Tour owner's championship with multiple different drivers.

Coby drove the No. 7NY in 13 events last season with one victory and six top-five finishes.
