This year's male and overall winner was Michael Norberg, who also is from Amherst. He finished with a time 30:50. He was more than 30 seconds ahead of the second-place finisher, Bradley Mish, of Hadley.

There were more than 5,000 participants in this year's event, which is part of a big weekend in Holyoke, going along with the parade that took place on Sunday. It also is viewed as a practice course for runners participating in more races later in the year, including the Boston Marathon. There are harriers who will run 6.2mile course multiple times to simulate 26.2-mile marathon distance, including participating in the main race.

Of the more than 5,000 harriers signed up, 3,813 registered finishes.

Benjamin Lasky, of Ludlow, was a top local finisher, coming in 14th at 33:41. Lasky has been a top 10 finisher in the past.

The race continued traditions of participants running for various charities and other causes, in honor of deceased loved ones, and of course, the running of the race in costume.

The current cost, as of press time, to enter the race, is \$35. The two-mile walk price was \$25 as of press time, but was expected to rise on March 13.

The weather, as of press time, is expected to be warmer than in previous years, near 60 and sunny.
